At 8:33 AM, approval passed of March 31, 2022 financial report following motion by Gabe Neill and second by Tye Day.

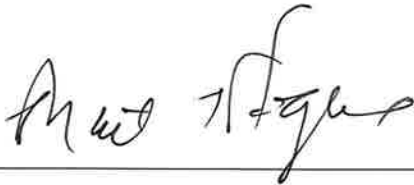
