
SOCOP Education Coordinator Michelle Cooper presented monthly activities report.

Following motion by Gabe Neill and second by John Mark Addison, board meeting minutes from Tuesday, January 20, 2026 unanimously approved at 8:54AM.



Suggestion was made by Attorney Ellis that SPUWCD should contact County Judge, State Representative and State Senator to discuss/request raising cap for special districts.

Following motion by Gabe Neill and second by Tim Swaringen, board voted unanimously to order a special election to increase the maximum tax rate allowable from .025 to .050 at 9:28AM


SOCOP Education Coordinator Michelle Cooper presented a monthly activities report, 8:38AM.

Field Manager Geoff Cooper presented monthly activities report, 8:45AM.


Board excused SOCOP Education Coordinator Michelle Cooper.
